ayne Memorial Hospital recently became a member of the Northeast Regional Cancer Institute. The move is expected to enhance Wayne Memorial's efforts to serve cancer patients and their families in the Hospital's service areas in Wayne and Pike Counties.

"The Northeast Regional Cancer Institute offers a variety of services that help us focus on cancer issues related specifically to our geographical area," said David Hoff, Chief Executive Officer of WMH. "While we have used many of the Institute's services in the past, such

as its cancer registry program, we believe our membership will boost efforts locally to battle specific types of cancer, such as colorectal cancer." Hoff pointed out that Cancer Institute data shows colorectal cancer rates in northeast PA are significantly higher than the rest of the country.

Cancer Institute programs, available in Wayne, Lackawanna, Luzerne, Wyoming, Pike and Susquehanna Counties, include cancer epidemiology research, community and healthcare professional education and survivorship programs.

The Guide even includes a section outlining area


camps and places to purchase wigs.

#### What is Epidemiology Research?

This is the third of a three part series focused on epidemiology research and clinical trial research as it relates to cancer.

articipation from individuals in studies has allowed medicine to evolve and improve. The same can be said for epidemiological studies, which aim to understand why something is happening. In an epidemiological study, no medication or treatment is administered, yet the information collected is just as valuable.

The Northeast Regional Cancer Institute is conducting a colorectal cancer risk factor study which aims to identify risk factors associated with

colorectal cancer and determine why colorectal cancer is 20% higher than state and national averages in Northeastern Pennsylvania.

Gathering this information, researchers at the Cancer Institute interview individuals in Northeastern Pennsylvania about their family history, medication history, occupation, diet, exercise routine, as well as drug and alcohol use.

"Only through research can we determine the risk factors associated with colorectal cancer. Knowledge of risk factors will allow our researchers to determine why rates of colorectal cancer are so high in Northeastern Pennsylvania compared to national averages," said Samuel M. Lesko, MD, MPH; Director of Research and Medical Director of the Cancer Institute. "You can help identify risk factors for colorectal cancer by participating in the study if asked."

These interviews are confidential and are conducted over the phone or in one-on-one meetings. Interviewers at the Cancer Institute use technology, which allows a computer to randomly select a phone number. The computer dials the phone number and record of that number is deleted at the end of the interview. The individual randomly called is asked to participate in the study.

by identifying risk factors for colorectal cancer that could help save family, friends, and neighbors.

In this random sample study, individuals are selected at random so that study participants represent the population of Northeastern Pennsylvania.

Since the study must remain random the Cancer Institute cannot enroll individuals who would like to volunteer for this study. Instead, the Cancer Institute encourages anyone invited to participate in this study to think about the benefit that he or she can supply

#### **Epidemiologists Presented at Statewide Research Summit**

ortheast Regional Cancer Institute
Epidemiologists presented current research
at the Statewide Research Summit along
with top leaders and cancer researchers. The
experts, who represent more than 250 public, private, academic and volunteer organizations, are
members of the Pennsylvania Cancer Control
Consortium (PAC3) – an initiative formed in 2001
to reduce the human and economic burden of cancer by creating the first-ever Pennsylvania
Comprehensive Cancer Control Plan.

Three current research projects were accepted for presentation at this year's conference. Samuel M. Lesko, MD, MPH; Director of Research and Medical Director at the Cancer Institute presented research on the use of adjuvant chemotherapy in stage III colorectal cancer in Northeastern Pennsylvania. Trudy A. Coleman, PhD presented a poster on cigarette smoking in Northeastern Pennsylvania and associated risk factors, a study

which was also done in collaboration with Dr. Lesko. Ilene S. Prokup, MS, RN, CS presented research that she and Dr. Lesko have been working on which examined factors associated with screening for colorectal cancer.

#### "Medicare 75% Rule" Limiting Patient Access To Inpatient Rehabilitation Hospitals

The Centers for Medicare and Medicaid Services (CMS) has recently presented a new set of criteria for acute rehabilitation *facilities* (*IRF*). The CMS criteria, known more commonly as the "75% Rule" was established to help reduce Medicare costs via health care services. The 75% Rule, in summary, requires that 75% of patients admitted to an IRF must have 1 of 13 diagnosis approved by CMS. If the IRF treats less than 75% of the CMS approved diagnosis, the IRF risks losing all reimbursement from Medicare for that fiscal year.

The American Medical Rehabilitation
Providers Association indicates that CMS estimates that "fewer than 13% of IRFs would qualify for Medicare reimbursement given the current patient populations they serve. Cancer, cardiac, and pulmonary patients, for example, are excluded from the 13 possible diagnosis that are eligible for acute rehabilitation." These patients that are excluded from the CMS IRF admissions criteria would be admitted to a lesser level of rehabilitation and med-

ical care in a skilled nursing center, to save Medicare costs.

The Allied Services Rehabilitation Hospital in Scranton is an acute rehabilitation hospital (IRF). This rehabilitation hospital with two rehabilitation units at Mercy Hospital and Moses Taylor Hospital treated over 2,500 patients in 2004; 81% of those patients treated were insured by Medicare. Because of the 75% Rule there were 45% less patients admitted for inpatient rehabilitation in 2005 with orthopedic and arthritis related conditions, these patients were ultimately treated in a lesser level of care.

The people of northeastern and central Pennsylvania can have a significant impact on the "75% Rule" access issues by contacting their state and national legislators.
